2. The deposit payment is confirmation of a booking and will also be the first down payment towards your event. Credit card details to be supplied as a security booking guarantee.
3. If you wish to cancel your event, you will automatically lose your deposit as per the Cancellation Policy on page 2 of the Booking Form.
4. The Customer is required to settle 50% of the total bill TWO months prior to the wedding date.
5. Final numbers/details and payments to be finalised ONE month before the wedding date.
6. A working table plan is to be supplied ONE month prior to your wedding date and a template
7. We will allow for three food changes on the day, any additional food changes will be billed to your account accordingly.
8. Abusive or destructive behaviour will not be tolerated on the premises.
9. An £8 corkage charge is payable per 750ml of wine, champagne or sparkling wine. No other alcohol, soft drinks or food is permitted unless authorised by the Clubhouse Manager.
10. Guests are responsible for arranging their own transport home.
11. We take no responsibility for loss of personal belongings on the premises. If damage is caused by any member of the party's group, then Bird Hills Golf Centre has the right to obtain payment in full for the damage from the booker or event organiser.
12. All food and drink charges amounted at your event, additional to those settled by the deposit and in advance balance of payment are to be paid on the day of the event by cash, cheque or credit/debit card.
